Malaysia's top court rejects Najib's bid to block AGC's appeal on house arrest royal addendum order

Malaysia's Federal Court dismissed former Prime Minister Najib Razak's objection against the Attorney-General's (AGC) application to appeal his bid for house arrest. Najib, currently serving a reduced six-year prison sentence for corruption linked to the 1MDB scandal, sought judicial review of an order for him to serve the remainder of his sentence under house arrest. The Court of Appeal had previously ruled in Najib's favour, but the AGC has appealed this decision. The Federal Court will deliver its ruling on the AGC's appeal on 28 April.

1 person dies every 2 hours in a road accident in Malaysia, official statistics show

In Malaysia, road accidents are a significant concern, with one fatality occurring every 1 hour and 56 minutes, accident happening and an approximately every 50 seconds, based on official statistics from March 2024 to March 2025. Accident numbers tend to surge during major festive periods, especially leading up to Hari Raya, with the highest number of accidents recorded in the days before the festival. Mondays are the most accident-prone day, while weekends are deadliest for road fatalities. In 2024, Malaysia had an average of 1,729 accidents and 14 deaths daily, with the road death rate at 0.8 per 100 accidents. Efforts such as the Op Selamat operation and a ban on goods vehicles during festive periods have reduced accidents. Malaysia ranks second in ASEAN for road fatalities, with a decline in the fatality rate over the past few decades

Anger mounts in Malaysia over Anwar's 'bailout' of Sapura Energy amid corruption probe



In a meeting on AI strategies and digital highlighted assets, he Malaysia's potential to lead in fields like Islamic digital assets and the halal industry, decision-making urging swift implementation. Anwar also stressed the importance of addressing cybersecurity threats and fostering industry confidence. advocated for He collaboration among various ministries institutions to create comprehensive approach, ensuring Malaysia's global competitiveness.

Malaysia's anti-corruption body, the Malaysian Anti-Corruption Commission (MACC), has launched an investigation into Sapura Energy amid public backlash over a proposed RM1.1 billion (US\$230 million) bailout for the company's unpaid vendors. Critics argue that taxpayers' money should be used to support the public health sector instead. While Prime Minister Anwar Ibrahim defends the bailout as necessary to settle Sapura's debts and prevent disruptions in the oil and gas sector, opposition figures, including Radzi Jidin and Hassan Karim, have criticised the move as a typical comparing it to previous bailout. government bailouts under former Prime Minister Mahathir Mohamad. investigation will focus on alleged money laundering and mismanagement related to Sapura Energy's operations in 2018.

Malaysia to tighten semiconductor regulations under US pressure

Malaysia is tightening semiconductor regulations under pressure from the United States to prevent high-end Nvidia chips from reaching China, which are crucial for Al development. Trade Minister Zafrul Aziz confirmed that the US is urging Malaysia to

monitor shipments of Nvidia chips closely to ensure they are delivered to the correct data centres and not diverted elsewhere. The US is also investigating whether Chinese Al firm DeepSeek has been using banned US chips. Additionally, Malaysia is probing a Singapore fraud case involving US servers potentially containing restricted chips, with transactions worth US\$390 million.

Malaysia's trade volume hits RM224bil in February, up 5.9%

trade performance Malaysia's in February 2025 grew by 5.9% RM223.9 billion, driven by a 6.2% rise in exports to RM118.3 billion and a 5.5% increase in imports to RM105.6 billion. The trade surplus improved by 12.2% to RM12.6 billion. Domestic exports, accounting for 82% of total exports, rose by 5.9%, while re-exports grew by 7.3%. Notable export growth was seen in electrical and electronic products, palm oil, and machinery. Imports increased due to higher demand for capital goods, consumption goods, and intermediate goods, with significant rises in imports from China, the US, and Taiwan.

Malaysia's economy to grow 4.5-5.5% in 2025, inflation manageable, says Bank Negara

Bank Negara Malaysia (BNM) projects Malaysia's economy to grow 4.5% to 5.5% in 2025, driven by strong domestic demand despite external uncertainties. expected Inflation is to manageable, with headline inflation between 2% and 3.5%, and core inflation between 1.5% and 2.5%. BNM remains confident in the economy's resilience, supported by ongoing structural reforms. In 2024, Malaysia's economy grew by 5.1% with moderate inflation. BNM also highlighted growth in digital payments and efforts to combat financial scams. while reporting a net profit of RM13.16 billion for 2024.

MAG orders 30 Boeing 737 aircraft for fleet modernisation

Malaysia Aviation Group (MAG) has announced its acquisition of 30 Boeing 737 aircraft, including 18 Boeing 737-8 and 12 Boeing 737-10 models, with an option for 30 more. These aircraft will replace the aging Boeing 737-800 fleet and will feature improved fuel efficiency, range, and passenger comfort. The 737-10 will also include lie-flat Business Class seats. This move aligns with MAG's long-term growth strategy, enhancing operational efficiency and sustainability. MAG currently operates 113 aircraft, with ongoing orders for additional 737s. The acquisition reflects MAG's commitment to growth, economic impact, and strengthening Malaysia's position in the global aviation industry, with benefits for job creation, tourism, and the broader economy.

Two Malaysian private hospitals, Sunway Medical Centre and Gleneagles Hospital Kuala Lumpur, were ranked among the world's top 250 hospitals, with Sunway Medical at 193rd and Gleneagles KL at 204th. Both hospitals

Thailand's Bumrungrad International Hospital in Bangkok ranked 100th. The rankings, compiled by Statista and Newsweek, are based on surveys of medical experts, patient experience, and hospital quality metrics. The top spot went to Mayo Clinic-Rochester in the US, followed by Cleveland Clinic and Toronto General-University Health Network.

Malaysia passes Carbon Capture, Utilisation and Storage Bill 2025

The Carbon Capture, Utilisation and Storage (CCUS) Bill was passed in Malaysia on 6 March, aiming to reduce CO2 emissions, combat climate change, and foster economic growth through development. However, CCUS implementation will only begin once the minister sets an operational date, and it will apply only to Peninsular Malaysia and the Federal Territory of Labuan. bill introduces While the establishment of a Malaysia CCUS agency to oversee matters like CO2 capture, transportation, and storage, concerns have been raised by NGOs such as Sahabat Alam Malaysia about



T15 fuel subsidy criteria may push consumers toward vehicle downgrades, boost EV shift

MIDF Research predicts that the introduction of the top 15% (T15) income bracket fuel subsidy eligibility criteria, expected to be finalised by mid-2025, may encourage consumers to opt for lower-cost internal combustion engine (ICE) vehicles or switch to electric vehicles (EVs) before tax exemptions for fully imported EVs expire at the end of the year. The revised excise duty set to take effect in January 2026 will raise prices for completely knocked down (CKD) cars by 10-30%. In February 2025, Malaysia's total industry volume (TIV) rose by 30.8% month-on-month but

**Good to know** 

The National Mosque of Malaysia (Masjid Negara) is one of Southeast Asia's most beautiful mosques, completed in 1965 after three years of construction. Located on the site of a former church, it stands as a symbol of national unity and independence. The mosque features a modern and progressive design, with a striking main dome adorned with turquoise tiles and shaped like a partly-opened umbrella, representing Malaysia's 13 states and the 5 pillars of Islam. A tall 73-metre minaret dominates the skyline, complemented by 48 smaller green domes. Surrounded by tranquil gardens and stunning architecture, the mosque offers a serene space for reflection. During Hari Raya, especially on the first day of Aidilfitri, the mosque becomes a hub of activity as Muslims gather for the Eid prayers and listen to a short *khutbah* (religious sermon). While traditionally, the prayers are attended by men, women are also welcomed and encouraged to join. Visitors are welcome to tour the mosque outside of prayer times, provided they follow the Islamic dress code and remove their shoes.
